

## Warranty on Expand Products

---

### **This warranty is in lieu of all other warranties, expressed or implied.**

Expand International AB's warranty offers customers confidence that they are considering a quality product, backed by a quality organization. Expand International AB, extends a limited warranty to the structural components and accessories of its products. The warranties described below are limited and do not apply to non-Expand items that might be added to an Expand product.

### **Lifetime warranty**

Expand International AB warrants the products below for the lifetime against manufacturer's defects in materials and workmanship.

All units of Expand 2000, Expand MediaWall, Expand QuickScreen, Expand MediaScreen, Expand BannerStand, Expand SmartStand, Expand PodiumCase, Expand PodiumBox, Expand M2, Expand MediaFabric, Expand BigFabric, Expand Tower, Expand MonitorStand, Expand BrochureHolder, Expand BrochureStand will, at the sole discretion of Expand, be repaired or replaced. Freight and turnaround time is subject to Expand International AB's standard terms and conditions.

### **Two year warranty**

All other products and accessories manufactured by Expand, are subject to a warranty period of two years from the date of shipment (from Expand International AB) against manufacturer's defect in materials and workmanship.

### **The conditions of the warranties are:**

- (1) the Expand products shall have been subject to only normal use and service and shall not have been misused, neglected, altered, improperly set up or otherwise damaged; and
- (2) there shall be no evidence of tampering or deliberate misuse or destruction.

Defects to Expand products will be determined solely by Expand International AB and not by any representative, distributor or dealer of, or for the company. Upon determination of a defect, Expand International AB's sole obligation will be to repair or replace the defective part.

Any claim against Expand International AB for defects in materials or workmanship must be in writing. Expand International AB must authorize the return of any alleged or defective part before it is returned. Returns will not be accepted without written consent and instructions from Expand. The party making the claim must prepay all shipping and transportation costs. Expand will not accept charges for parts purchased unless the conditions of the warranty have been satisfied.

Expand reserves the right to substitute, discontinue, alter or modify any product or part thereof, at any time without prior notice. In such cases Expand may, at its sole discretion, substitute the warranted product.

No Expand representative, distributor or reseller is authorized to assume for Expand any other obligations or liabilities in connection with the product, or alter the terms of this warranty in any way.

Expand shall not be liable for damages, including special, incidental or consequential damages arising out of or in connection with the performance of this Expand product or its use by the owner.
